8. General meeting and its powers :

General meeting will comprise of life ordinary members.

It is essential to conduct general meetings twice a year. Members should receive notice of General meeting prior to seven days of its convention. This notice convey about Agenda, Cenuue, date and time of meeting.

For coavening the meeting, 2/3 members should attend. If meeting is adjourned for want of quorum, the same will be convened on the same day after two hours of scheduled time. This meeting does not require quorum fulfilment.

If discussion on the topics of General meeting is to be effected or if any other important matter is to be effected or if any other important matter is to be talked about in meeting, the members should submit written suggestions to the president prior to atleast three days before the probable date otherwise

The right to accept or reject the eleventh hour suggestions will be reserved with Executive Board.

1. Sanction to the agreed upon matters by Executive Board
2. Approval of the minutes of last meeting and sanction to the ensuing estimates.
3. Exploration of income surces and fortifying economic state of society.

9. Executive Board of society :

Executive Board of society shall comprise of 6 members and if which 5 will be office bearers and 1 will be members. Details are as follwos.

- 1) president 2) Vice President 3) Secretary
- 4) Joint secretary 5) Treasurer and 6) members

10. Duration of executive Board

The duration of Executive Board will be 5 years.

11. Duties and powers of executive Board

- 1) Keeping annual report, balance and expenditure and details of fiscal affairs before the general body meeting for appro.
2. Auditing of the accounts matter of society by auditor and publishing it.
- 3) Safeguarding the movable and immovable property of society and ensuring its proper use.
4. prepatation of the society's estimates.

12. Election of executive Board.

Executive Board will be elected after every five years by ordinary members by majority.

- 2) Jurisdiction of Society  
Society's jurisdiction is nationwide
- 3) Audit year  
1. April to 31 March. 1
- 4) Member of society  
1. Life member  
2. ordinary member.
- 5) Member and their registration method  
Any Indian major citizen who agrees upon with the purpose of society by abiding its rule can apply in prescribed form to the executive board and consequent upon its consent can only become the member. by depositing entry fees Rs. 5/- (as per form)  
Rs. 1001 annual subscription or person submitting immovable property values more than Rs. 1001 can become life member.  
A) Life member  
B) Ordinary Member  
person subscribing Rs. 101 can become ordinary member.
- 6) Age limit  
Any Indian citizen completing 18 years of age can become member.
- 7) Cancellation of membership
  - 1) Failure to remit annual subscription will lead to cancellation of membership
  - 2) Membership will be cancelled if member is sentenced by court of law for immoral crime
  - 3) If member expires
  - 4) If member suffers from mental debility.
  - 5) If member tenders resignation
  - 6) If member impedes or obstructs the society work.

13. Election Rules :

1. The members against whom the annual subscription or any other society's debt is pending, shall not be able to contest election.
2. Only ordinary members atleast for one year shall have the right to vote.
3. Election will be conducted either by raising the hands or through secret ballot.
4. president will act as election officer.
5. Election programme will be proclaimed by the president of society (Election officer) before 14 days of its conduct.

14. Nominating trustee on Vacant posts.

After election, vacant post caused due to death, resignation or any other reason should be filled in by executive board by majority.

15. Meeting notice.:

Notice should be issued in such a way that the members will receive it prior to seven days of its actual conduct.

16. Meeting notice to Executive Boards:

Notice of the meeting of Executive Board should be issued to facilitate its receipt prior to seven days of its conduct.

17. Emergency Meeting :

Intimation regarding emergency meeting should be given 24 hrs through notice book by signing on it.

18. Office-bearers and their rights :

A) President :

1. President will be Ex-Office chairman of meeting of Executive Board and shall have control over the affairs of society.
2. Organization of General meetings, supervision over day today working and control over sub-branches offices.
3. Control over economic matters and right for decision on any matter by consensus of Executive board shall rest with president.

18. B) Vice President :

In absence of president, vice president shall have the right to perform all work of president.

C. Secretary :

1. Maintaining accounts of society.
2. Bank transaction.
3. Convening General meeting and writing minutes of the meeting.
4. Writing annual fiscal details, getting audited by auditor and publishing the same.
5. The secretary shall have the right to keep Rs. 500 cash at hand.
6. Right for recruitment with the approval of executive Board.

D. Joint secretary :

In absence of secretary, joint secretary will perform secretary's work and at other times shall assist secretary.

E. Treasurer :

Maintenance of accounts of income and expenditure of society writing of the accounts with the help of secretary.

F. Members :

1. Attending meetings of Executive Board.
2. Counselling in the interest of society and helping office bearers.

19. Society's fund and income :

1. Fee and donation from members of Government subsidy.
2. Donations either in cash or kind, movable and immovable property or deposits.

20. Change in rules :

If the change is to be effected either in rule or rules, approval may be taken in general meeting by 2/5 members (Adoption as per society Registration Act. 1860 section 12.)

21. Regarding loan or deposits :

Looking to the nature of working of the society and economic necessary, society can take loan from any private or cooperative bank and will repay it and shall utilize it for the work of society.

22. Movable property :

In accordance with the decision of Executive Board, movable property can be disposed of with the approval of charity commissioner.

23. Bank accounts :

In accordance with the law, account can be opened up in a recognised bank and right to sign on cheque should be reserved with president and secretary.

24. Method of maintaining list of members :

In accordance with the society Registration act 1860, section 4, list of members will be maintained.

25. Dissolution :

If it is not possible to run society or if it is required to be closed, action in this behalf should be taken in pursuance of society subact 1860, section 13 and 14.
